अहमदाबाद: 2008 में हुए धमाकों में 49 दोषी

अहमदाबाद , ८ फरवरी (भाषा)।

अहमदाबाद में वर्ष 2008 में हुए सिलसिलेवार बम धमाकों के मामले में यहां की विशेष अदालत ने मंगलवार को 49 लोगों को दोषी करार दिया। इन धमाकों में कुल 56 लोगों की मौत हुई थी जबिक करीब 200 अन्य लोग घायल हुए थे।

न्यायाधीश एआर पटेल ने गुजरात के सबसे बड़े शहर में हुए 21 सिलसिलेवार धमाकों में आरोपी 28 लोगों को संदेह का लाभ देते हुए बरी कर दिया। अदालत ने कहा कि दोषियों की सजा की अवधि पर सुनवाई बुधवार को शुरू होगी। अदालत ने जिन लोगों को दोषी करार दिया है उनमें सफदर नागोरी, जावेद अहमद और अतीकुर रहमान भी शामिल हैं। निचली अदालत ने धमाकों के करीब 13 साल बाद फैसला सुनाया

है और मामले में 77 अभियुक्तों के खिलाफ सुनवाई पिछले साल सितंबर में पूरी कर ली थी।

विशेष लोक अभियोजक अमित पटेल ने बताया कि अदालत ने 49 अभियुक्तों को गैरकानुनी गतिविधि (निषेध) अधिनियम की धारा-16, जो आतंकवाद से जुड़ा है और अन्य प्रावधानों, भारतीय दंड संहिता की धारा-302 (हत्या), धारा-120बी (आपराधिक साजिश) के तहत दोषी करार दिया है।
