ORDER OF THE COMMITTEE-2 FOR IDENTIFICATION OF WILFUL DEFAULTERS PASSED IN PROCEEDINGS CONDUCTED AT HEAD OFFICE ON 08.07.2025

In terms of RBI Master Directions RBI/DoR/2024-25/122 OR.FIN.REC.No. 31/20.16.003/2024-25.30 July 2024, a meeting of the Committee for Identification of Wilful Defaulters of the Bank was held on 21.05.2025. The Identification Committee concluded that events of wilful default in the Borrower's account(s) had occurred and gave its approval for issuance of Show Cause Notice for identifying the following person(s) as wilful defaulters:

- M/s Nafto Gaz India (P) Ltd. (Borrower)
- Sh. Mahdoom Bava (Director)
- Sh. Mahdoom Kadar (Director)

Accordingly, Show Cause Notice of 21 days was issued on 22.05.2025 to the above Borrower i.e. M/s Nafto Gaz India (P) Ltd. & its related parties who were involved in the events of default. They were informed, if they so desire, they can make a representation to the Bank within 21 days from receipt of notice, as to why they should not be classified as wilful defaulters. In spite of service of the said show cause notice(s), no reply/representation was made by Borrower and its related parties.

The Identification Committee in its meeting held on 08.07.2025, after due consideration of the facts on record observed that the Borrower & its related parties defaulted in payment/repayment obligations to the Bank and were involved in events of default, are to be identified as wilful defaulters on the following ground(s) specified in above mentioned Master Circular of RBI:

Siphoning of Funds

On review of the audited financial statements of the borrower company for the year ending on 31.03.2009, 31.03.2010 and 31.03.2011 along with Statement of Affairs as on 08.10.2012, the followings are the outstanding balances of Secured as well as Unsecured Creditors of the company.

Prima facie, on observations of these balances, it appears that the unsecured loans existing as on 31.03.2011 of approx. Rs. 199.42 crore had been repaid by the company prior to any repayment of dues towards secured creditors. It also indicates that most of the unsecured Creditors have been paid after 30.03.2011, after obtaining loan from the lender banks. It shows that borrower has siphoned off bank's funds.

Further, in spite of repeated requests borrower has not supplied necessary clarification to the forensic auditor thereby indicating intentional non-cooperation.

The borrower misrepresented itself to be a subsidiary of a reputed foreign company (Nafto Gaz of Ukraine). However, no shareholding of Naftogaz of Ukraine in the borrower company was found.

Avigo PE Investment Ltd. (Mauritius-based entity) acquired stake from a UK entity named "Naftogaz Corporation Ltd." This UK entity had no connection with Naftogaz of Ukraine, suggesting the entire linkage was constructed to mislead lenders. Use of a similarly named entity without substance further reinforces misrepresentation.

The MOU based on the record only provided for a technical tie-up and revenue sharing limited to specific contracts, but did not establish any parent-subsidiary relationship. Yet, the borrower used this MOU to project itself as a subsidiary/representative of Naftogaz of Ukraine, again indicating intent to mislead lenders.

All the above events constitute deliberate misrepresentation of facts by the borrower to induce confidence in lender banks for obtaining loans. And the loan amount was later siphoned off by the borrower.

A Mauritius-based PE investor, controlled by an individual (Mr. Tejesh Srivastava), acquired stake in the borrower company through a questionable transfer from an unrelated UK entity. This offshore routing of investments and change in control suggests the possibility of funds being routed through non-transparent means.

The fabricated corporate structure and misleading affiliations may indicate that borrowed funds were used to create artificial linkages or fund such entities pointing to diversion of funds.

ORDER OF THE COMMITTEE FOR IDENTIFICATION OF WILFUL DEFAULTERS:

The Identification Committee-2, constituted in consonance with RBI guidelines and after due consideration of the overall facts, the charges levelled against the Borrower and its related parties, decided to identify the following persons as wilful defaulters:

The Committee directed to issue the Order accordingly and to serve the same upon the borrower and its related parties.

However, the Committee directed that the above-named persons are free to make a written representation against the order of Identification Committee, within a period of 15 days from the date of receipt of this order to the Review Committee-2 headed by the Executive Director of the Bank at the following address: Punjab National Bank, SAM Division, Corporate Office, 3rd Floor, Plot No. 4, Sector 10, Dwarka New Delhi, PIN: 110075. It is further informed that an opportunity of personal hearing shall be provided by the Review Committee headed by the Executive Director of the Bank before final declaration.
